Company Projects

- Mississippi, USA: 1000 acres with 16 wells in production. Operating under the subsidiary KFG Petroleum Corporation.
- On February 14, 2019, the Company purchased for \$113,088, 15% of Hillcrest Petroleum Ltd.'s 75% interest in four reactivation wells in Hillcrest's West Hazel Field, Western Saskatchewan, with the option to participate in additional drilling of in that area of 220 acres. The Company has not yet received distributions. In Wilkinson County, MS the Company's commitment in a 7,460' hole of 6% working interest for \$46,000 has been delayed until next year because of high water in the Mississippi River. . KFG's interest is 11.25%. One well has gone to 100% water and plans are to recomplete it uphole in a virgin oil zone. KFG has \$2.4 million CAD in tax losses that carries forward.

- Management Discussion Outlook For Q3 2019:

The collapse in oil prices has hurt cash flow for the last quarter. KFG has agreed to participate with another company in a well in Wilkinson County, MS with a 6% working interest for \$48,000 to casing point. Unfortunately, high water from the Mississippi River has prevented that well from being drilled until next year.

In March 2020 the World Health Organization declared coronavirus COVID-19 a global pandemic. This contagious disease outbreak, which has continued to spread, and any related adverse public health developments, has adversely affected workforces, economies, and financial markets globally, potentially leading to an economic downturn. It is not possible for the Company to predict the duration or magnitude of the adverse results of the outbreak and its effects on the Company's business or results of operations at this time.

The Company is continuing to seek opportunities in North Texas and Mississippi with industry partners.
